All information must be submitted by 3/20/2023 for the 4/17/2023 tax return filing deadline.

Tax return information submitted after the deadline may require the filing of a six-month extension. After the April tax deadline, once you provide your tax return information, most returns are completed within three weeks.

You will receive a \$50 invoice when your extension is filed. This payment will be credited to your invoice when the returns are completed.

Available Discounts

EARLY BIRD -- If all your tax documents are submitted by 3/15/2023, a 20% discount will be applied to your tax return invoice.

DEPENDENT -- Your children's tax returns will be prepared for half to standard fee.

Included Services
